

**Sands Lifestyle Shopping Rewards**  
**19<sup>th</sup> July – 14<sup>th</sup> September, 2019**

1. The event is opened to all Sands Rewards members.
2. Participants must be 21 years of age or older.
3. Participants cannot be barred, must have a valid membership card and be in good standing with Venetian Macau Limited.
4. The event period is from 19<sup>th</sup> July to 14<sup>th</sup> September 2019.
5. The event consists of two (2) parts of lucky draw (session 1 &2), which will be respectively held at 7:00pm on 17<sup>th</sup> August 2019 (Session 1) and on 14<sup>th</sup> September 2019 (Session 2) at Parisian Gaming.
6. The Sands Lifestyle Shopping Rewards “Lucky Draw” qualifying criteria are listed as below:

**6.1 Method 1: Points Earning**

- a) Sands Rewards Members who accumulate twelve (12) points or above within the Points Earning Period from any slot and/or table (excluding Electronic Table Games) from their respective property (i.e. Venetian Casino, The Plaza Macao Casino, Sands Cotai Central Himalaya Gaming, Pacifica Gaming, Himalaya High Limit, Parisian Gaming and all APEX) shall be eligible to redeem one (1) lucky draw entry. **6.2 Method 2: Spending & Staying at Sands Resorts Macao**

**6.2.1 Method 2a: Spending at Sands Resorts Macao**

- a) Shoppers spend on every MOP500 or above in one (1) receipt at all retail shops, kiosks, F&B outlets, CotaiTravel™, CotaiTicketing™ and Recreation (“Shops”) at The Venetian® Macao, The Plaza™ Macao, Sands® Cotai Central and The Parisian Macao are entitled to redeem one (1) lucky draw entry.
- b) Terms and Conditions for lucky draw entries redemption in Method 2a are listed as below:
  - i. The aggregate amount referred to in clause 6.2.1a shall be shown in one (1) same day valid machine-printed receipt, and valid receipt shall be issued to the customers by the Shops.
  - ii. Receipts priced in Hong Kong Dollar (HKD) or Chinese Yuan (RMB) will be considered as 1:1 rate with Macau Pataca (MOP) under this Promotion.
  - iii. For the avoidance of doubts, the shopper must present same day receipt on the same day of the transaction, with the aggregate amount referred to in clause 6.2.1a above, for redeeming the lucky draw entries. Receipts of less than MOP500 or that are not of the same day of the redemption of the lucky draw entries do not qualify for redemption of the lucky draw entries.

- iv. Receipts for redeeming the lucky draw entries are only valid for redemption before 11:00pm on the same issued date (except the Acknowledge of Purchase from CotaiTicketing™). Receipts issued after 9:00pm are valid for redemption until 11:00pm of the next day.
- v. If the shopper redeem the lucky draw entries by the Acknowledge of Purchase from CotaiTicketing™, only ticket purchase of shows held between the Entries Redemption Period (19<sup>th</sup> July until 14<sup>th</sup> September 2019) will be eligible for lucky draw entries redemption.
- vi. Credit card sale slips, hand-written or reprinted invoices shall not be accepted for redemption purposes of the lucky draw entries.
- vii. If the purchases are made with any vouchers, the amount of the shoppers' own payment (cash, credit card, Sands Rewards Points, Sands Rewards Dollars or other e-wallet payment such as Alipay, WeChat Pay, mPay, etc.) should be equal or above MOP500 to be eligible for lucky draw entries redemption. - viii.   - One (1) same day valid machine-printed receipt;
  - The purchased merchandise to which each receipt refers (except for purchase of services);

  - Valid Sands Rewards membership card;
  - Proof that shopper scanned the Shopper ID QR code on WeChat and followed Sands Resorts Macao WeChat official account to get the Shopper ID;
  - If the shopper will redeem the lucky draw entries by the Acknowledge of Purchase from CotaiTicketing™, he/she will also need to present the related show tickets upon entries redemption.

- xii. Guests with receipts from The Venetian® Macao, The Plaza™ Macao, Sands® Cotai Central or The Parisian Macao can only redeem related lucky draw entries at the designated Lucky Draw Entries Redemption Location from The Venetian® Macao, The Plaza™ Macao, Sands® Cotai Central or The Parisian Macao.

**6.2.2 Method 2b: Staying at Hotels**

- a) Hotel guests from The Venetian® Macao, Four Seasons Hotel Macao, Conrad Macao, Cotai Central, Holiday Inn Macao, Cotai Central, The St. Regis Macao, Cotai Central and The Parisian Macao (“Hotels”) can redeem lucky draw entries based on the room night spend during the stay.
- b) Terms and Conditions for lucky draw entries redemption are listed as below:
- i. One (1) lucky draw entry could be redeemed with one (1) room night of stay.
  - ii. Lucky Draw Entries Redemption Voucher will be issued to the hotel guests who do the hotel check-in registration. And the guests will need to approach designated Sands Rewards Counters for lucky draw entries redemption.

  - vii. If the hotel room is recorded as comp room in the hotel system, the room night(s) from that hotel room are not qualify for any lucky draw entries.
  - viii. Cotai hotel guests can only redeem related lucky draw entries at the designated Sands Rewards Counters at The Venetian® Macao, The Plaza™ Macao, Sands® Cotai Central or The Parisian Macao.

**6.3 Method 3: Sands Rewards WeChat New Binder Free Entry**

- a) Sands Rewards WeChat New Binder are eligible to redeem complimentary lucky draw entry base on below matrix within the whole event period.
- Gold member will be entitled with ONE (1) free entry
  - Ruby member will be entitled with FIVE (5) free entries
  - Diamond and APEX member will be entitled with TEN (10) free entries

**6.4 Method 4: Alipay Sands Lifestyle Digital Card Holder Free Entry**
